United Kingdom Events

These are the Terms and Conditions of The Fire Fighters Charity. The event may be organised by contracted tour operators/contracted tour providers. Participants are to ensure the contracted tour operators/contracted tour providers Terms and Conditions are also read in conjunction with those set out below. It is a condition that all participants comply with both The Fire Fighters Charity's and tour operators/contracted tour providers Terms and Conditions.

- You participate at your own risk, be advised some events may have a minimum/maximum age limit. If you are refused entry to
 any United Kingdom based events, any additional costs incurred are your responsibility.
- For this challenge we require a registration fee payment. Unless the event is cancelled by The Fire Fighters Charity, this fee is non-refundable once you have been accepted on the event.
- By registering for this challenge you are pledging to raise the minimum sponsorship (where applicable) by the event date as

- The Fire Fighters Charity may at its sole discretion change routes or withdraw places on the event if it is believed to be in its best interest to do so.
- If you do anything to void your insurance, including not declaring a pre or existing medical condition, you are fully responsible
 for paying any and all associated costs including travel and accommodation to and from the event.
- By signing this form you also acknowledge that photographs and written quotations may be taken of you during the event and used to publicise future events and the work of The Fire Fighters Charity in general.
- If you have registered as a FUNDRAISING TEAM LEADER you understand and accept that should a member of your team withdraw by the provider's event registration deadline they can be replaced by a new member; provided the new member pays the full registration fee. After the event registration deadline no replacement members can be added.
- If you have registered as a FUNDRAISING TEAM LEADER and a member(s) of your team withdraws AFTER the event registration deadline, the minimum amount of sponsorship that must be raised by the remaining members will not be reduced i.e. the team must still raise the minimum sponsorship of the withdrawing member(s).
- For the purpose of the fundraising contract between the participant and The Fire Fighters Charity, the participants shall not be deemed to be participating in the event as either a volunteer (as defined under The Fire Fighters Charity's normal practices and procedures) nor as a consumer and specifically The Unfair Contract Terms Act 1977 shall not apply. Accordingly, the participant may wish to take out some personal insurance for the event.
